4. You can sell your home, provided the sale price is enough to pay what you owe.

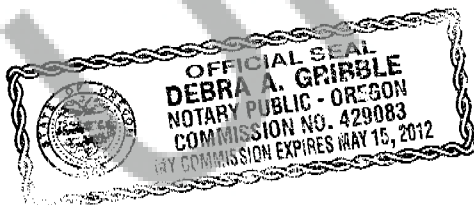
