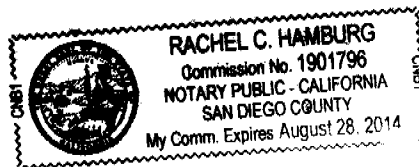

NOTICE TO RESIDENTIAL TENANTS



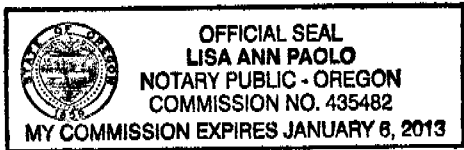

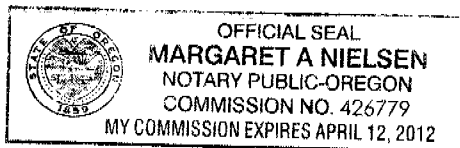
