



Unless the lender who is foreclosing on this property is paid before the sale date, the foreclosure will go through and someone new will own this property. The new owner that buys this property at the foreclosure sale may be willing to allow you to stay as a tenant instead of requiring you to move out after 90 days or at the end of your fixed term lease. After the sale, you should receive written notice informing you that the sale took place and giving you the new owner's name and contact information.
