EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

A portion of vacated and repartitioned Block 5 of "Resubdivision of a portion of McLoughlin Heights" more particularly described as follows: beginning at the intersection of the Easterly boundary of relocated Uhrmann Road and the Southerly boundary of Daggett Avenue from which the monument marking the center quarter-section corner of Section 20, Township 38 South, Range 9, East of the Willamette Meridian, bears North 89°49'West 60.0 feet and South 0°51' West 839.1 foot distant (said point being also the Northwest corner of vacated and repartitioned Block 5 of "Resubdivision of a portion of McLoughlin Heights"); thence following the Northerly and Easterly boundaries of said Block 5, South 87° 46' East 36.54 feet to a point; thence around a circular curve to the right (which has a radius of 119.49 feet, a central angle of 75° 22' 40", and a long chord which bears South 50°05'20" East 146.1 feet) a distance of 157.3 feet to a point, thence South 12°26'20" East 102.1 feet to a point; thence North 82°01' West 174.7 feet to a point on the Easterly boundary of relocated Uhrmann Road and the Westerly boundary of said Block 5; thence North 0° 51' East 170.5 feet, more or less, to the point of beginning.
