MODIFICATION OF NOTE AND TRUST DEED

RECITALS:

- A. On <u>August 14, 2007</u>, <u>Dwayne W McIntosh and Barbara J McIntosh</u> executed and delivered to Lender a promissory note ("Note") in the amount of \$\frac{129,500.00}{}.
- B. To secure performance of the Note, Grantor executed and delivered to Lender a trust deed ("Trust Deed") dated August 14, 2007 recorded in the official records of Klamath County, Oregon as document # _2007-014371_.
- C. Lender herein currently is the owner and holder of said Note and Trust Deed and Grantor is the current owner of the real property described in said Trust Deed.

AGREEMENT:

The parties hereby modify said Note and trust deed as follows:

- 1. The monthly payment is changed to \$_891.48_ per month, beginning __July 1, 2012___
- 3. The interest rate of the loan is changed from <u>6.875%</u> to <u>4.125%</u> for the period beginning <u>June 1, 2012</u> through <u>maturity</u>.
 - 4. The maturity date is changed from <u>September 1, 2037</u> to <u>June 1, 2027</u>.

Except as modified above, the terms of the original Trust Deed and Note shall remain unchanged and in full force and effect. Lender's consent to this modification does not waive Lender's right to require strict performance of the Trust Deed and the Note as changed above nor obligate Lender to make any future modifications.
