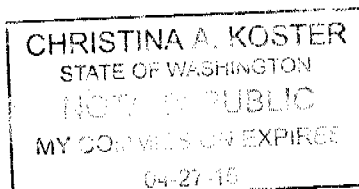

requiring you to move out after 90 days or at the end of your fixed term lease.
