



NOTICE OF DEFAULT AND ELECTION TO SELL

Requires the payment of rent that is not substantially less than fair market rent for the property, unless the fort is rounded or subsidized due to a federal state or local subsidy;

and
Was entered into prior to the date of the foreclosure sale.
The name of the trustee and the trustee's mailing address are listed on this notice. Federal law may grant you additional rights including a right to a longer notice period. Consult a lawyer for more information about your rights under federal law. You have the right to apply your security deposit and any prepaid rent toward your current obligations under your rental agreement. If you want to do so, you must notify your landlord in writing and in advance that you intend to do so.
