In the event that Lender fails to provide any required notice of the right of rescission, Lender waives any subsequent security interest in the Grantor's principal dwelling that is created by this Security Instrument.

This Security Instrument will be offered for record in the same county in which the Master Form was recorded.

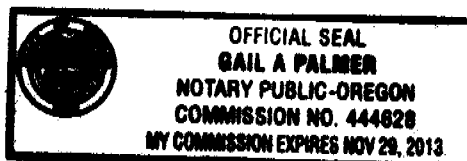
