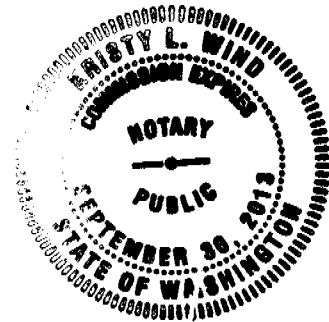
#### JURISDICTION AND VENUE
