Lot 4 in Block 8, THE TERRACES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

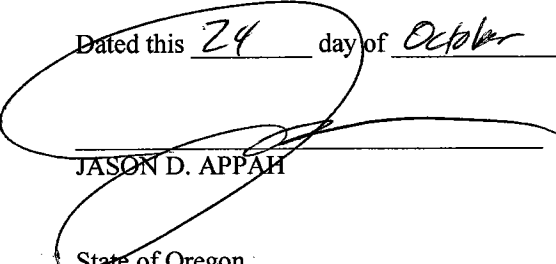
