The true and actual consideration for this conveyance is \$1.00 and a gift.

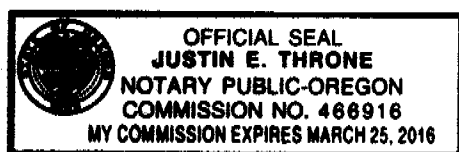

# EXHIBIT "A"

A parcel of land situated in Section 3, 4, 5, 9 and 10, T. 34 S., R. 7½E.W.M., Klamath County, Oregon, more particularly described as follows:

Beginning at a point on the West bank of Wood River where the South boundary of the land heretofore conveyed by Abner Weed, et ux, to George W. Loosley by Deed recorded in Vol. 31, Page 81, Deed Records of Klamath County, Oregon, intersects the said West bank of Wood River; thence West 470 feet; thence South 96 feet; thence S. 19°05 'W. 715 feet; thence N. 79°57 ' W. 1492 feet to Southwest corner of Lot 22 of Section 4, T.. 34 S., R. 7½ E.W.M.
