Lot 37, 38, 54 and 60 in Tract 1378-PLEASANT VISTA STAGE 2, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.



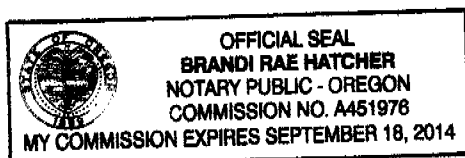
