KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anyway appertaining, situated in the County of **KLAMATH**, State of Oregon, described as follows, to wit:

Parcel 2 of Land Partition 1-09, replat of Land Partition 22-08 in the NW1/4 of Section 3, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, filed December 22, 2010 in Volume 2010-014490, Microfilm Records of Klamath County, Oregon.
