

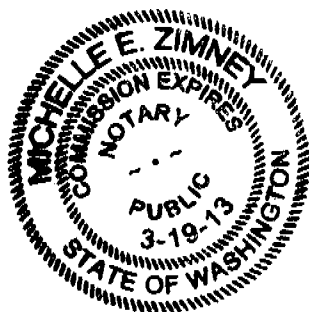

CORRECTED/COMPLETED LEGAL DESCRIPTION:

All that portion of Government Lot 6 in Section 34, Township 34 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point described by two consecutive courses from the intersection of the Westerly line of Lalakes Avenue with the Northerly line of Schonchin Street in the Townsite of West-Cliloquin, Oregon, namely North 59° 30' West 116.3 feet; and North 42° 39' West 295.0 feet; thence South 47 degrees 21' West 53.0 feet; thence Northwesterly at right angles 150.00 feet; thence Northeasterly at right angles 53 feet; thence Southeasterly at right angles 150 feet to the point of beginning, also known as Tract 121 Spinks Subdivision.
