ESTOPPEL DEED

THIS INDENTURE is made between Adin Automotive Products, Inc. (Adin), a California Corporation, hereinafter referred to as Grantor, to Putnam, LLC, an Oregon Limited Liability Company, hereinafter referred to as Grantee.

WITNESSETH

Adin and Putnam have entered into a SETTLEMENT AND MUTUAL RELEASE AGREEMENT. As part of the settlement, Grantor has agreed to convey Grantor's present interest in the property to Grantee which Grantee accepts in full satisfaction of the indebtedness secured by the Contract and other consideration in the Settlement Agreement

NOW THEREFORE, Grantor does hereby grant, bargain, sell and convey to Grantee and Grantee's heirs, successors and assigns, all of Grantor's interest in and to the following described real property, with the tenements, hereditaments and appurtenances belonging or in any way appertaining, as situated in Klamath County, State of Oregon, to-wit:

A parcel of land situated in the SE¼ of Section 2, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being a portion of Lot 1, Lot 2 and a portion of Lot 3 of Bailey Tracts and more particularly described as follows:

Beginning at a point on the west line of Homedale Road from which the Northeast corner of Bailey Tracts bears North 00°02'00" East 130.50 feet; thence along said west line South 00°02'00" West 697.92 feet; thence leaving said west line South 89°53'28" West 308.64 feet to the west line of Lot 3 of Bailey Tracts; thence along said west line and the west lines of Lots 2 and 1 of Bailey Tracts North 00°01'24" East 697.92 feet; thence North 89°53'28" East 308.76 feet to the point of beginning, containing 4.95 acres, more or less, with bearings based on County Survey No. 5044.
