EXHIBIT "A"
LEGAL DESCRIPTION

PARCEL 1:

A portion of land in the E1/2 of the NE1/4 of Section 19 Township 28 South, Range 8 East of the Willamette Meridian, shown as parcel 4 on Survey Map No. 1343 filed in the office of the Klamath County Surveyor, Klamath County, Oregon, more particularly described as follows: Beginning at the SW corner of the North Beaver Marsh Addition to Beaver Marsh which point is marked by a 1" iron pipe; thence S0° W 766.37 feet to a 1" iron pipe and the true point of beginning. Thence S 73° 04' 30" East 780.75 feet to a 5/8" iron pin, thence South 16° 59' W 297.0 feet to a 5/8" iron pin. Thence North 73° 04' 30" West 630.54 feet to a 1/2" iron pipe. Thence North 0° 05' East 310.30 feet to the true point of beginning. EXCEPTING therefrom that portion conveyed to the County of Klamath in the State of Oregon by Warranty Deed recorded May 20, 1969 in Volume M69 page 03765.

PARCEL 2:

A tract of land situated in the E1/2 of the NE1/4 of Section 19, Township 28 South, Range 8 East of the Willamette Meridian, in the County of Klamath, State of Oregon, described as follows: Beginning at the Southwest corner of the SE1/4 of the NE1/4; thence North 89° 59' East (by record North 89° 58' 35" East) 529.50 feet; thence North 16° 59' East 649.67 feet; thence North 73° 04' West 690.54 feet to a 1/2 inch iron pipe set in the West line of the E1/2 of NE1/4; thence South 0° 05' West (by record South 0° 04' 30" West) 840.01 feet to the point of beginning.
