RE-ASSIGNMENT OF BENEFICIAL INTEREST IN DEED OF TRUST

- A. On January 28, 2011, NOAH executed and delivered to U.S. Bank, as Agent Bank, that certain Assignment of Deed of Trust by Beneficiary (the "NOAH Assignment"), pursuant to which NOAH granted, assigned, transferred, and set over to U.S. Bank, as Agent Bank (i) all of NOAH's beneficial interest in and under that certain Deed of Trust dated January 28, 2010 pertaining to the Iris Glen Townhome Apartments in Klamath Falls, Oregon, among Iris Glen Townhomes, LLC, an Oregon limited liability company, as Grantor, First American Title Insurance Company as Trustee, and NOAH as Beneficiary (the "Iris Glen Deed of Trust"), together with the notes, monies, and obligations described or referred to in the Iris Glen Deed of Trust, the interest thereon, and all rights and benefits whatsoever accrued or to accrue under the Iris Glen Deed of Trust, and (ii) NOAH's entire right, title, and interest in and to certain other documents executed in connection with the Iris Glen Deed of Trust (the "Iris Glen Loan Documents") and all rights created or conveyed by such Iris Glen Loan Documents, as more particularly described in the NOAH Assignment.
- **B.** The Iris Glen Deed of Trust was recorded January 28, 2011 as Fee 2011-001079 in the Official Records of Klamath County, Oregon, and encumbers certain real property in Klamath County, Oregon, more particularly described on the attached Exhibit A. The NOAH Assignment to U.S. Bank, as described in Recital A, was recorded on January 28, 2011 as Fee 2011-001080 in the Official Records of Klamath County, Oregon.

NOW, THEREFORE, the parties agree as follows:

1 - RE-ASSIGNMENT OF BENEFICIAL INTEREST IN DEED OF TRUST - IRIS GLEN LLC

AGREEMENT:

- 1. For value received, U.S. Bank, as Agent Bank, hereby sells, grants, transfers, conveys, and re-assigns to NOAH (i) all of the beneficial interest of U.S. Bank, as Agent Bank, in and under the Iris Glen Deed of Trust, together with the notes, monies, and obligations described or referred to in the Iris Glen Deed of Trust, the interest thereon, and all rights and benefits whatsoever accrued or to accrue under the Iris Glen Deed of Trust, and (ii) the entire right, title, and interest of U.S. Bank, as Agent Bank, in and to the Iris Glen Loan Documents and all rights created or conveyed by the Iris Glen Loan Documents.
- 2. U.S. Bank, as Agent Bank, hereby covenants to and with NOAH that U.S. Bank is the holder of the beneficial interest in the Iris Glen Deed of Trust and the other interests conveyed pursuant to the NOAH Assignment, that it has good right to sell, grant, transfer, convey, and re-assign the same to NOAH, and that the person signing below on behalf of U.S. Bank is duly authorized to execute this Re-Assignment.
