and



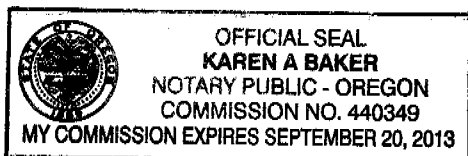
