## SUBORDINATION AGREEMENT of LEASE

A parcel of land lying in the NE½SE½ of Section 2, Township 39 South, Range 9 East, W.M., Klamath County, Oregon; said parcel being a portion of that property described in that Warranty Deed to Harold J. Atkinson and Marilyn L. Atkinson, recorded April 4, 1995 in Book M95, Page 8192, Klamath County Record of Deeds; said parcel being that portion of said property lying Easterly of a line at right angles to the center line of the relocated Klamath Falls – Lakeview Highway at Engineer's Station 126+50.00 and included in a strip of land 51.00 feet in width, lying on the Southerly side of said center line, which center line is described as follows:

Beginning at Engineer's center line Station 75+21.60, said station being 131.80 feet East and 1.47 feet South of the West quarter corner of Section 2, Township 39 South, Range 9 East W.M.; thence North 89° 44' 04" East 2,984.00 feet; thence South 89° 52' 38" East 2,309.15 feet to Engineer's center line Station 128+14.75 Back equals 128+15.00 Ahead, on said center line.
