SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 1st day of February, 2013, by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem OR 97301-1266, hereinafter called the "First Party" and Navy Federal Credit Union, with an address of 5550 Heritage oaks Blvd., Pensacola, FL 32526 hereinafter called the "Second Party",

WITNESSETH:

On or about October 5, 2011, Michael s. Flanakin, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (State whether mortgage, trust deed, security agreement)
