DECLARATION OF FORFEITURE

I, NATHAN J. RATLIFF, under oath, state as follows:

1. This declaration pertains to that certain Land Sale Contract (Contract) between **ROGER WHITE and CAROLYN WHITE**, as Sellers, and **DEANNA GONZALES, ART GONZALES, and LAURIE GONZALES**, as Purchasers, which agreement was signed and entered into on the 6th day of September, 2010, without a memorandum having been recorded by a county recording officer, which contract covers that certain real property situated in Klamath County, Oregon, known as 5719 Delaware Avenue and 5721 Delaware Avenue, Klamath Falls, Oregon 97603, and which is more particularly described as follows, to-wit:

Lot 54 of CLOVERDALE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

2. An Affidavit of Mailing Notice of Default, with a copy of the Notice of Default attached (Notice), was recorded on August 2, 2012, as Instrument No. 2012-008467 of the Official Records of Klamath County, Oregon.

3. The default described in the Notice was not cured within the time specified, as required by ORS 93.915.

4. Purchasers' claim against Sellers, prosecuted in the Circuit Court of the State of Oregon, Klamath County, in Case No. 1203050CV, was decided in favor of Sellers pursuant to the General Judgment Denying Claim for Relief entered in that case on March 29, 2013.

5. The Contract is hereby declared forfeited.

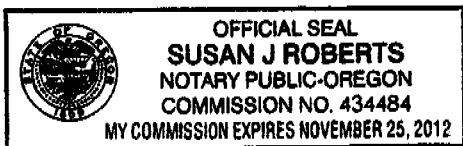

NOTICE OF DEFAULT

This Notice of Default is given with respect to the contract described below, which contains a forfeiture remedy, pursuant to the provisions of ORS 93.905-93.940.

1. *Description of Contract.* Land Sale Contract (Contract) between **ROGER WHITE and CAROLYN WHITE** as Sellers, and **DEANNA GONZALES, ART GONZALES, and LAURIE GONZALES** as Purchasers, which agreement was signed and entered into on September 6th, 2010 without a memorandum being recorded by a county recording officer.

2. *Property.* The property which is the subject of the Contract is known as 5719 Delaware Avenue and 5721 Delaware Avenue, Klamath Falls, Oregon 97603, and is more particularly described as follows:

Lot 54 of CLOVERDALE, according to the official plat thereof on file
In the office of the County Clerk of Klamath County, Oregon.

3. *Nature of Default.* The default consists of Purchasers' failure to make timely payment of the amount due under the Contract. Specifically, Purchasers failed to make the agreed-upon monthly payments of \$860.36 by the agreed-upon dates, namely: October 6, 2011; March 6, 2012; April 6, 2012; May 6, 2012; June 6, 2012; and July 6, 2012.

4. *Amount of Default.* The amount of default is \$4,482.16 (which represents six months of non-payment minus a \$180 over-payment and a \$500 third-party payment), plus interest at an agreed-upon 6% per annum from October 6, 2011.

5. *Date Contract Will Be Forfeited.* The Contract will be forfeited if the default is not cured by (60 DAYS FROM TODAY'S DATE)

6. *How to Cure Default.* The default will be cured if by October 3, 2012, the following occurs:


6.1 The sum of \$4,482.16, plus interest at 6% per annum from October 6, 2011 until payment in full, is *received*, on account of the Contract, by Parks & Ratliff, P.C.
