EXHIBIT "B" LEGAL DESCRIPTION

A tract of land situated in Government Lots 3, 4, 7 and 8 and the N1/2 S1/2 of Section 17, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a monument (all monuments are 5/8 inch iron pins with Tru-Line Surveying plastic cap, unless otherwise noted) on the Northwesterly right of way line of the Southern Pacific Railroad, from which the corner common to Sections 8, 9, 16 and 17 bears North 28°47'57" East 3,642.74 feet and also being the point of beginning of that Road Easement described in Volume M88, page 2525, Microfilm Records of Klamath County, Oregon; thence North 54°46'27" West, along said road easement 877.30 feet to a monument marking the end of said easement; thence North 35°13'33" East 30.00 feet to a monument; thence North 26°07'00" West, 201.55 feet to a railroad spike driven into sandstone; thence North 02°51'48" West, 323.68 feet to a "U" bolt on the West side of a willow tree; thence North 02°18'49" West, 1,119.07 feet to a railroad spike driven into the root on the West side of a willow tree; thence continuing North 02°18'49" West, 25 feet, more or less, to the Mean High Water Line of Klamath River; thence Southwesterly, along said waterline, to the Northwest corner of said Lot 8; thence Southerly to the SW 1/16 corner; thence Southeasterly, towards the South 1/4 corner, to a point on the Northwesterly right of way line of the Southern Pacific Railroad; thence along said right of way line to a point which bears South 34°35'38" West, 300.00 feet from the point of beginning; thence North 54°46'27" West, 198.00 feet; thence North 34°35'38" East, 270.00 feet; thence South 54°46'27" East, 198.00 feet to a point on said railroad right of way line; thence North 34°35'38" East, 30.00 feet to the point of beginning.
