(A) **"Security Instrument"** means this document, which is dated April 16, 2013, together with all Riders to this document.

(B) **"Borrower"** is DONALD R. TILLER AND BRENDA TILLER, HUSBAND AND WIFE. Borrower is the trustor under this Security Instrument.

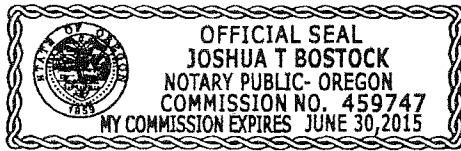
