THIS NOTICE OF TERMINATION (this "Notice") is made this 8th day of January, 2013 by Invenergy Solar Development LLC, a Delaware limited liability company with its principal place of business at 1 South Wacker Drive, Suite 1900, Chicago, Illinois 60606 ("Grantee").

WHEREAS, Grantee and John & LeeAnn Paddock (collectively the "Owner") entered into that certain Lease and Easement Agreement dated December 28, 2010, as evidenced by that certain Memorandum of Solar Lease and Easement Agreement of even date recorded May 2, 2011 as Document 2011-005381 (collectively, the "Agreement"), which encumber that certain real property in Klamath County, Oregon as more particularly described on Exhibit A attached hereto and incorporated herein by this reference; and

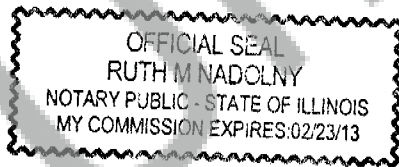
