Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A portion of the S1/2 SW1/4 NW1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:

Beginning at a point which lies North 1°12' West a distance of 331.4 feet along the section line and North 88°57' East a distance of 342 feet from the iron axle which marks the one quarter section corner common to Sections 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian and running thence; continuing North 88°57' East a distance of 67.5 feet to a point; thence North 1°12' West parallel to the section line a distance of 331.4 feet, more or less to an iron pin on the North line of the S1/2 SW1/4 NW1/4 of Section 11; thence South 88°58' West along the North line of the S1/2 SW1/4 NW1/4 of Section 11, a distance of 67.5 feet to an iron pin; thence South 1°12' East a distance of 331.5 feet, more or less to the point of beginning, said tract being the W1/2 of that tract of land conveyed to Clara A. Clifton by J.J. Winter, et ux., by Deed recorded in Book 178, page 173, Deed Records of Klamath County, Oregon, and further being described as Tract 9 of WINTERS TRACTS, according to the unrecorded plat thereof.
