This Security Instrument will be offered for record in the same county in which the Master Form was recorded.

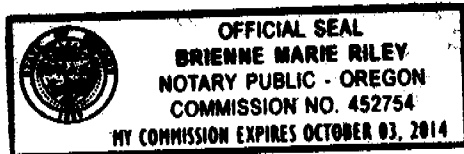

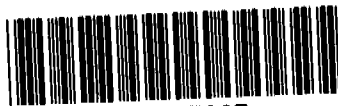
