MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated October 30, 2013, is made and executed between Klamath Falls Center, LLC, an Oregon limited liability company ("Grantor") and Pacific Crest Federal Credit Union, whose address is P O Box 1179, Klamath Falls, OR 97601 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated June 11, 2009 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

Parcel B:

Parcels 1 and 3 of Land Partition No. 32-08, a replat of Parcel 3 of Land Partition No. 42-01, located in the Southeast 1/4 and the Southwest 1/4 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, filed December 22, 2008 in Volume 2008-016694, Microfilm Records of Klamath County, Oregon. EXCEPTING THEREFROM all that portion conveyed to the State of Oregon by and through its Department of Transportation recorded November 29, 2012 in Volume 2012-013241, Microfilm Records of Klamath County, Oregon.

The Real Property or its address is commonly known as NW1/4 SE1/4 SEC. 01 T.39S. R.09E. W.M., Klamath Falls, OR 97601.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Interest only loan changed to a 5 year term amortized over 20 years, with a new maturity date of 10/30/2018.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

GRANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS MODIFICATION OF DEED OF TRUST AND GRANTOR AGREES TO ITS TERMS. THIS MODIFICATION OF DEED OF TRUST IS DATED OCTOBER 30, 2013.

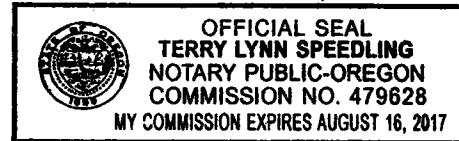
