The true and actual consideration for this conveyance is **\$129,000.00**.

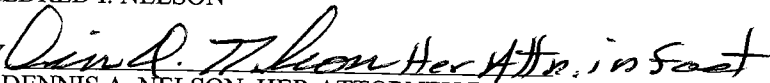
