## MEMORANDUM OF LEASE AMENDMENT

This Memorandum of Lease Amendment is dated as of October 30, 2013 and is between Grant F. Brown and Lois M. Brown (collectively "Lessor") and Sierra-Cascade Nursery, Inc. ("Lessee").

The parties entered into a Commercial Farm Lease (the "Lease") dated November 1, 1998 that granted to Lessee, among other rights, the right to purchase approximately 194 acres in Klamath County, Oregon described in Exhibit A (the "Premises").

In a Memorandum of Agreement dated on or about November 4, 2010, the parties agreed that Lessor would be able to remove approximately 20 acres of the Premises from the purchase option in exchange for a reduction of the purchase price owed by Lessee.

Lessor is presently working to complete a land partition with Klamath County Planning Department to create a separate parcel for the acreage that will be retained by Lessor.

Lessor anticipates that additional time will be required to complete the land partition, and therefore on or about October 30, 2013, the parties entered into Amendment No. 1 to Commercial Farm Lease (the "Amendment") to extend the period for exercise of the purchase option and completion of the purchase accordingly.

The parties therefore agree as follows:

- 1. Purchase Option Extension. Under the terms of the Amendment, the Lessor granted to Lessee an extension to exercise Lessee's exclusive purchase option to a date that is 10 days after Lessee receives notice from Lessor that the Klamath County land partition is completed and the Premises is ready for sale.
- 2. Incorporation of Lease Provisions. Reference is made to the Lease and the Amendment for the complete statement of the rights and obligations of the Lessor and Lessee. Copies of the Lease and the Amendment are retained at the offices of the Lessor and Lessee set forth below. The execution and recording of this Memorandum shall not limit, increase, or in

any manner affect any terms of the Lease, the Amendment or the rights, interests, or obligations of the Lessor and Lessee.

Successors and Assigns. This Memorandum, the Lease, and the Amendment shall bind and inure to the benefit of the parties and their respective heirs, successors, and assigns consistent with the provisions of the Lease and the Amendment.
