THIS INDENTURE, Made this 10/28/2013, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Wells Fargo Bank, NA, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1201314CV, in which Wells Fargo Bank, NA, was plaintiff(s) and Unknown Heirs of Gary Joe Woodward, Deceased; Gary Joe Woodward, JR; and Occupants of the Premises was defendant(s), in which a Writ of Execution, which was issued on 12/31/2012 directing the sale of that real property, pursuant to which, on 4/22/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$165,965.66, towels Fargo Bank, NA, who was the highest and best bidder, that sum being the highest and best sum bid therefore.
