The true and actual consideration for this conveyance is **\$170,000.00**.

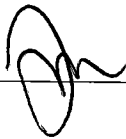

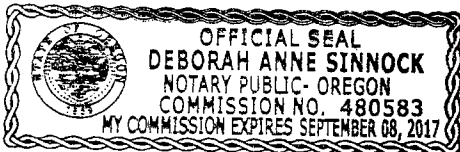
