TRUSTEE'S DEED

THIS INDENTURE is made this **December 19, 2013**, between **Valerie A. Tomasi**, hereinafter called trustee, and **First Community Credit Union**, hereinafter called the grantee. The true and actual consideration for this conveyance is \$134,304.75.

WITNESSETH:

RECITALS: Reference is made to a certain trust deed ("Trust Deed") made, executed and delivered by **Danelle Kinzie**, as grantor, to **AmeriTitle**, as trustee, in favor of **SOFCU Community Credit Union**, as beneficiary, dated July 24, 2008, and recorded on July 29, 2008, as Recording No. 2008-010753, in the mortgage records of Klamath County, Oregon. SOFCU Community Credit Union is now known as **First Community Credit Union**.

In the Trust Deed, the real property therein and hereinafter described was conveyed by the grantor to the trustee to secure, among other things, the performance of certain obligations of the grantor to the beneficiary. A copy of the notice of sale was mailed by first class and certified mail with return receipt requested to the lastknown address of the fiduciary or personal representative of any person named in ORS 86.740(1), promptly after the trustee received knowledge of the disability, insanity or death of any such person. The mailing, service, and publication of the notice of sale, and the mailing of the notice required under ORS 86.737(1), are shown by affidavits and/or proofs of service duly recorded prior to the date of sale in the county records, those affidavits and proofs, together with the Notice of Default and Election to Sell and the notice of sale, being now referred to and incorporated in and made a part of this deed as if fully set forth herein. The undersigned trustee has no actual notice of any person, other than the persons named in those affidavits and proofs as having or claiming a lien on or interest in the real property, entitled to notice pursuant to ORS 86.740(1)(b) or (1)(c).

The undersigned trustee, on **December 19, 2013**, at the hour of 11:00 a.m., in accord with the standard of time set forth in ORS 187.110, and at the place so fixed for sale, in full accordance with the laws of the State of Oregon and pursuant to the powers conferred upon the trustee by the Trust Deed, sold the real property at public auction to the grantee for the sum of \$134,304.75, the grantee being the highest and best bidder at the sale, and that sum being the highest and best bid for the property.
