This is a Mortgage Amendment as defined in M.S 287, 01 Subd 2, and as such does not secure a new or increased amount of debt.

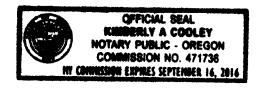
1. As of **DECEMBER 01, 2013**, the amount payable under the Note and Security Instrument (the "Unpaid Principal Balance") is U.S. \$83,826.20.

2. The Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of the Lender. Interest will be charged on the Unpaid Principal Balance at a yearly rate of 3.75%, beginning DECEMBER 01, 2013. The Borrower promises to make monthly payments of principal and interest of U.S. \$441.86, beginning on the 1<sup>st</sup> day of DECEMBER 2013, and continuing thereafter on the same day of each succeeding month until principal and interest are paid-in-full. - 4. Nothing in this Modification shall be understood or construed to be a satisfaction or release in whole or in part of the Note and Security Instrument. Except as otherwise specifically provided in this Modification, the Note and Security Instrument will remain unchanged and in full effect, and the Borrower and Lender will be bound by, and comply with, all terms and provisions thereof, as amended by this Modification.
