SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 13th day of November 2013, by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem OR 97301-1266, hereinafter called the "First Party" and Wells Fargo, N.A. ISAOA, with an address of 8009 34th Ave. S., Suite 600; Bloomington, MN 55425 hereinafter called the "Second Party",

WITNESSETH:

On or about April 27, 2012, Matt Grant and Kimberly Grant, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (State whether mortgage, trust deed, security agreement) (herein called the "First Party Lien") on the Premises, to secure the sum of \$30,000.00, which lien was recorded on May 7, 2012, in the Records of Klamath County, Oregon as Document No. 2012-004751.

The First Party is the legal and beneficial owner of the First Party Lien and the debt secured thereby which is evidenced by one or more promissory notes made by the Borrower in favor of the First Party.

Borrower's current first mortgage loan on the Premises securing an estimated unpaid principal balance of \$188,972.34, in favor of Mortgage Electronic Registration Systems, Inc.(MERS) is a separate corporation that is acting solely as a nominee for Security National Mortgage Company, a Utah corporation recorded on December 5, 2008, in the Records of Klamath County, Oregon, as Document No. 2008-016129 which lien and the underlying debt shall be terminated upon such refinancing.

The First Party and the Second Party agree that the principal amount of such refinancing shall not exceed \$188,778.00, with interest thereon at a rate not exceeding 4.25% per annum, and a maturity date of 360 Months or 30 Years, and shall be secured by a certain

In construing this Agreement, and where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this agreement shall apply equally to corporations and to individuals.
