THIS INDENTURE, Made this 1/13/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Adrienne Jeannette Hill, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1103326CV, Klamath County Sheriff's Office Case Number J13-0012 in which Onewest Bank, FSB, its Successors in Interest and/or Assigns was plaintiff(s) and Unknown Heirs and Devisees of Anna Lucille Goudy, Deceased; Lucille A. Goudy; Donald L. Detroit; John F. 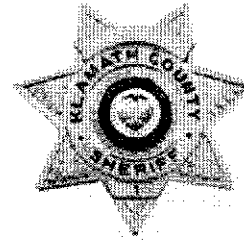

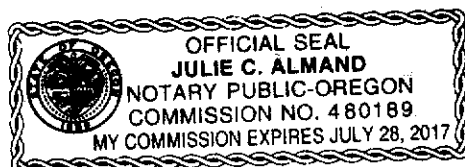



