RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1201265CV, Klamath County Sheriff's Office Case Number J13-0033, in which Nationstar Mortgage LLC was plaintiff(s) and The Heirs and Devisees of Dennis J. Bennett; Theresa Bennett; Occupants of the Property was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 3/20/2013, directing the sale of that real property, pursuant to which, on 6/7/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$117,745.77, to Nationstar Mortgage LLC, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 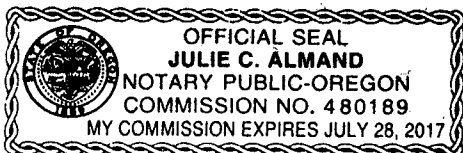



