TRUSTEE'S DEED

THIS INDENTURE, made this <u>3rd</u> day of January 2014, between Joseph E. Kellerman, hereinafter called Trustee, and Kent and Linda Pederson, Husband and Wife, hereinafter called the Second Party.

RECITALS:

Bruce C. Bonner and Toni L. Bonner, as Grantors, executed and delivered to Aspen Title & Escrow, Inc., as Trustee, for the benefit of AmericanWest Bank, Successor-in-interest by merger to PremierWest Bank, as Beneficiary, a trust deed recorded on November 2, 2004 at Volume M04, page 75289-94, Microfilm Records of Klamath County, Oregon.
