THIS INDENTURE, Made this 12/09/2013, by and between Klamath County, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Homestreet Bank, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1202981CV, in which Homestreet Bank was plaintiff(s) and Sonia L. Mendez, Persons or Parties Unknown Claiming Any Right, Title, Lien or Interest in the Property Described in the Complaint Herein was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 02/11/2013, directing the sale of that real property, pursuant to which, on 04/29/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$62,546.34, to Homestreet Bank, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. After Grantor received funds in the amount bid at the sale, a certificate of sale, as required by law, was duly executed and delivered to the purchaser.

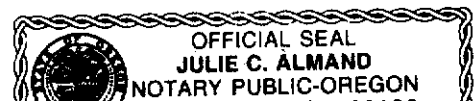
AND COMMONLY KNOWN AS 1202 DIVISION STREET, KLAMATH FALLS, OREGON
