## QUITCLAIM DEED

WITNESSETH, that the said Grantor, for one dollar (\$1.00) the receipt whereof is hereby acknowledged, does hereby remise, release and quitclaim unto the said Grantee forever, all the right, title, interest and claim which said Grantor has in and to the following described parcel of Land, and improvements and appurtenances thereto in the County of Klamath, State of Oregon, legally described as:

Parcel 2 of Land Partition 129-06, being a replat of Parcel 3 of Minor Land Partition 81-16 situated in the NE 1/4 of Section 2, Township 35 South, Range 7 East of the Willamette Meridian.
