EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

All those portions of SE1/4 NW1/4 and N1/2 SW1/4 in Section 30, Township 39 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, lying Southeasterly of the U.S.R.S. "C" Canal and Southwesterly of the U.S.R.S. "C-G" Cutoff Channel.

PARCEL 2:
