THIS INDENTURE, Made this 2/6/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee;

WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1202287CV, Klamath County Sheriff's Office Case Number #1202287CV in which Wells Fargo Bank, N.A., its Successors in Interest and/or Assigns was plaintiff(s) and Brent E. Fisher; Theresa M. Fisher; Ray Klein, Inc., an Oregon Corporation, DBA Professional Credit Service; and Occupants of the Premises was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 4/29/2013, directing the sale of that real property, pursuant to which, on 7/8/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$\$207,073.97, to Wells Fargo Bank, N.A. its Successors in Interest and/or Assigns, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

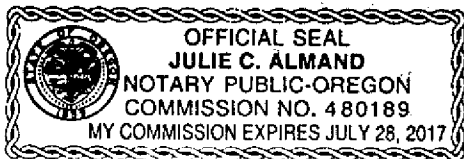


