THIS INDENTURE, Made this 1/15/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and CitiMortgage, Inc., hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1202687CV, Klamath County Sheriff's Office Case Number J13-0046, in which CitiMortgage, Inc., its Successors in Interest and/or Assigns was plaintiff(s) and Nicolau A. Morgado, Jr.; Thomas E. Dehart; Tammy A. Wales AKA Tammy Ann Wales; Capital One Bank; Onyx Mini Warehouse; Randy Simmington; and Occupants of the Premises was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 4/29/2013, directing the sale of that real property, pursuant to which, on 7/8/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$178,713.83, to CitiMortgage, Inc., its Successors in Interest and/or Assigns, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 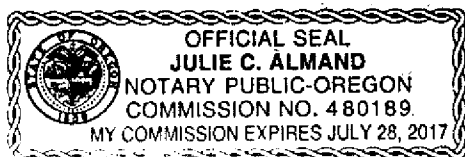
