MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated February 14, 2014, is made and executed between Klamath Aluminum Products, An Oregon Corporation, Doing Bsiness As Basin Glass & Aluminum ("Grantor") and Pacific Crest Federal Credit Union, whose address is P O Box 1179, Klamath Falls, OR 97601 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated March 4, 2009 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

Original Deed of Trust was recorded on 3/4/2009 with recording number 2009-003217 in Klamath County, Oregon.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

Modification of term and new maturity date of 1/30/2024. Interest rate modification. Variable rate based on 5yr TCM plus 3.50 adjusted at 5yr anniversary and floor rate of 6.50%.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorsers to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.
