THIS INDENTURE, Made this 12/10/2013, by and between Klamath County, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage Association, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1200028CV, in which Onewest Bank, FSB was plaintiff(s) and Unknown Heirs and Devisees of Geoffrey E. Nelson, Deceased; the Estate of Geoffrey E. Nelson, Deceased; United States of America, Secretary of Housing and Urban Development; and Persons or Parties Unknown Claiming any Right, Title, Lien, or Interest in the Property Described in the Complaint Herein was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 1/31/2013, directing the sale of that real property, pursuant to which, on 4/24/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$98,000.00, to OneWest Bank, FSB, who was the highest and best bidder, that sum being the highest and best sum bid therefore. At the time of the sale, the purchaser paid the amount bid for the property to the grantor or grantor's predecessor in office. 


