THIS INDENTURE, Made this 2/25/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and US Bank National Association, as Trustee for the Structured Asset Securities Corporation Mortgage Pass-Through Certificates Series 2006-BC4, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1200187CV, Klamath County Sheriff's Office Case Number J13-0032 in which US Bank National Association, as Trustee for the Structured Asset Securities Corporation Mortgage Pass-Through Certificates Series 2006-BC4 was plaintiff(s) and Kelly Jean Collins; Michael Harlan Collins; and Occupants of the Premises was defendant(s), in which a Writ of Execution, which was issued on 3/19/2013, directing the sale of that real property, pursuant to which, on 7/10/2013 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$22,100.00, to US Bank National Association, as Trustee for the Structured Asset Securities Corporation Mortgage Pass-Through Certificates Series 2006-BC4, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 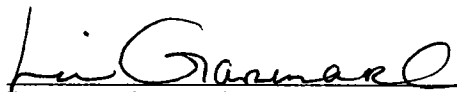

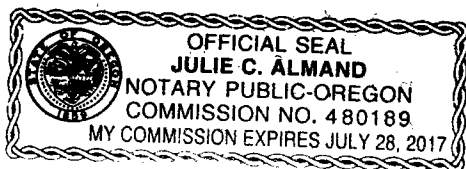

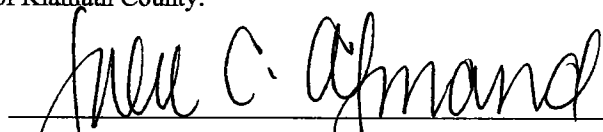
