THIS INDENTURE, Made this 2/25/2014, by and between Frank Skrah, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Federal National Mortgage ASsociation, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1200005CV, Klamath County Sheriff's Office Case Number J13-0044, in which Everbank, Successor by Merger to Everhome Mortgage Company was plaintiff(s) and Diane Margaret Campbell; Susan R.
