Morehouse; Valerie B. Morehouse; Kyle A. Justman A/K/A Kyle Andrew Justman A/K/A Andrew K. 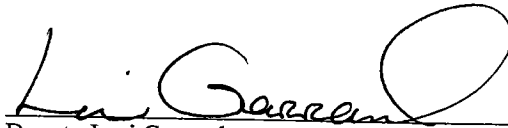

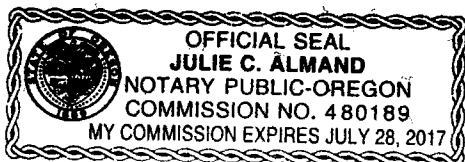

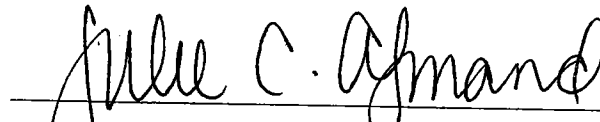
