RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1201862CV, Klamath County Sheriff's Office Number J13-0069, in which Wells Fargo Bank, NA was plaintiff(s) and Unknown Heirs of David M. Beeson, Deceased; Michael B. Beeson; Terry D.
