AND MORE COMMONLY KNOWN AS 3221 DIAMOND STREET, KLAMATH FALLS, OREGON 97601.

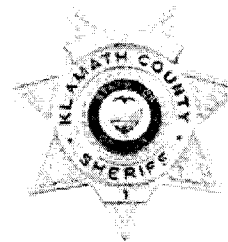

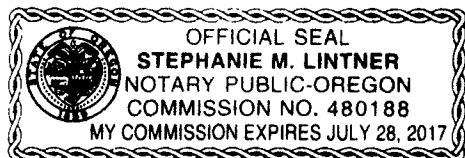


