SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 25th day of April 2014, by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem, OR 97301-1266, hereinafter called the "First Party" and Universal American Mortgage Company, LLC. Its Successors and/or Assigns, As Their Interest May Appear, with an address of 15550 Lightwave Drive, Suite 200, Clearwater, FL 33760 hereinafter called the "Second Party",

WITNESSETH:

On or about April 16, 2012, Virginia L. Bustos, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (herein called the "First Party Lien") on the Premises, to secure the sum of \$30,000.00, which lien was recorded on May 2, 2012, in the Records of Klamath County, Oregon as Document No. 2012-004584.

The First Party is the legal and beneficial owner of the First Party Lien and the debt secured thereby which is evidenced by one or more promissory notes made by the Borrower in favor of the First Party.

Borrower's current first mortgage loan on the Premises securing an estimated unpaid principal balance of \$80,637.55, in favor of ABN AMRO Mortgage Group, Inc. recorded on July 25, 2006, in the Records of Klamath County, Oregon, as Document No. M06-14980 which lien and the underlying debt shall be terminated upon such refinancing.
